By summons and complaint, each dated March 8, 2013, Plaintiff, Kimberly Denise Jones, p/k/a Lil' Kim (the "Plaintiff") commenced an action (the "Action") against, among others, KBY Properties Group LLC ("KBY"). This office represents KBY in the Action.

On behalf of KBY, I filed and served an answer with affirmative defenses and counterclaims on May 29, 2013 and, on behalf of Plaintiff, you filed a reply to the counterclaims on July 19, 2013. No pleadings or other papers have been served upon KBY since July 19, 2013.

Issue has been joined and on July 19, 2014, the Action will have been pending for more than one year without prosecution against KBY.

Pursuant to CPLR 3216, demand is made upon the Plaintiff to resume prosecution of the Action and to serve and file a note of issue within ninety (90) days after receipt of this letter. If Plaintiff defaults in complying with such demand, Plaintiff's default will serve as the basis for a motion by KBY for dismissal of the Action against it for unreasonably neglecting to proceed.
