Lanham Act

a. c. The defendant Tom Joyner along with the above listed defendants falsely associated Blondell Mitchell with having and spreading Aids/HIV by stated that;

“That Blondell Mitchell (a unique name) a black accountant from Iowa has Aids/HIV”;

“That Blondell Mitchell (a unique name) a black accountant from Iowa has been intentionally spreading Aids/HIV;”

“That Blondell Mitchell (a unique name) a black Accountant from Iowa is a serial Killer.”

The defendants have intentionally done this in bad faith and their statements are Literally False Per Se (See exhibits A to N). They have and continue to **actually deceive** their audience. The above listed defendants' **Literally False** statements misrepresent Blondell Mitchell (**a unique trade name** used in the service she provides as an Accountant).

d. The defendants' deception of associating Blondell Mitchell with Aids/HIV is material and has harmed, stigmatized and have ultimately ruined Blondell Mitchell career as an accountant along with her future and affected every facet of her life. The defendants' statements are intentionally literally false per se (See attached Exhibits A to N) and have ruined every facet of Blondell Mitchell life.

e. The defendant **placed their literally false associations per se** (See attached Exhibits A to N) **into interstate commerce** by way of National Syndication, promotions, broadcast and re-broadcasts by Radio and internet, destroying Blondell Mitchell (a unique trade name) services as an Accountant one of the many rights to be protected along with her life.

f. Blondell Mitchell has been and is continuously injured as a result of the defendants' literally False per se association with having and spreading Aids/HIV or the virus associated with the disease (See attached Exhibits A to N) in her career, life, future and every facet of her life to
