**AGREED FINAL JUDGMENT INCORPORATING
TERMS OF SETTLEMENT AGREEMENT**

BE IT REMEMBERED that the Plaintiff Vincent Paul Young, Jr. ("Young" or "Plaintiff") and Defendants Ron Peoples, Carol Peoples and Peoples Financial Services, Inc. ("Peoples" or "Defendants" and together with Young, collectively referred to hereinafter as the "Parties") have agreed to settle and compromise all claims made the basis of the above-captioned lawsuit, and no longer desire to prosecute claims against one another. This lawsuit was filed to enforce the Settlement Agreement and Release of All Claims (the "Agreement") entered into by the Parties in settlement of Cause No. 2012-33871, styled as *Vincent Paul Young, Jr. v. Ronnie T. Peoples, individually and d/b/a Peoples Financial Service, Inc., et al.*, in the 281st Judicial District Court of Harris County, Texas (the "Prior Lawsuit"). As a part of their settlement agreement, the Parties agreed to the entry of this Agreed Final Judgment Incorporating Terms of Settlement Agreement in any future lawsuit filed by Young relating to the enforcement of the Parties' Agreement, a copy of which is attached hereto as Exhibit A and is incorporated herein by reference. Upon consideration of the Parties' Agreement as set forth in this Agreed Final Judgment, the pleadings, and other evidence on file, the Court is of opinion that the Parties' Agreement should be approved.

IT IS, THEREFORE, ORDERED, ADJUDGED, and DECREED that Plaintiff Young have and recover from Defendants judgment for:

1. \$2,000,000.00 plus interest at a rate of 5% from the date of execution of the Agreement;
2. Reasonable and necessary attorneys' fees in the amount \$2,500.00
3. Court costs; and
4. Post judgment interest on all of the above at the rate of 5%, compounded annually, from the date this judgment is entered until all amounts are paid in full.

IT IS FURTHER ORDERED, ADJUDGED and DECREED that this judgment is final, disposes of all claims and all parties, and is appealable. Plaintiff Young shall be allowed such writ and process as may be necessary in the enforcement and collection of this Agreed Final Judgment. All relief not expressly granted herein is denied.


